Products must be purchased and installed between **July 1, 2017** and **June 30, 2018**. Rebate applications must be postmarked by **July 15, 2018** to qualify for the 2017-2018 rebate program.

Please allow 6-8 weeks for payment.

Payment processing may take longer if information is missing on the application.
