

3. Attach a sales receipt from your dealer, including a copy of the Energy Star Guide from the appliance, manufacturer's name, model/serial number of equipment purchased, and date installed. Equipment must be purchased and installed between **July 1, 2014 and June 30, 2015**. Rebate applications must be postmarked by **July 15, 2015** to qualify for the **2014** rebate program.
