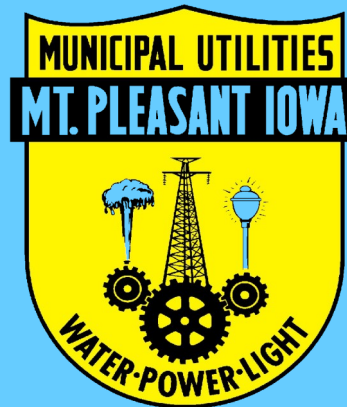

2. After equipment is installed and operating, **FULLY COMPLETE THIS REBATE APPLICATION**, including signature. Any missing information may delay processing of rebate. The Utilities reserves the right to inspect equipment installation prior to the issuance of rebates.

3. Attach a sales receipt from your dealer, including a copy of the Energy Star Guide from the appliance, manufacturer's name, model/serial number of equipment purchased, and date installed. Equipment must be purchased and installed between **July 1, 2017** and **June 30, 2018**. Rebate applications must be postmarked by **July 15, 2018** to qualify for the **2017-2018** rebate program.

Please allow 6-8 weeks for payment. Payment processing may take longer if information is missing on the application. **Thank you** for participating in the Residential and Small Commercial **ENERGYSTAR®** Products Program.
