PEDDLERS & SOLICITORS: Permit is valid **only** for the applicant listed on page one of permit. **(Anyone assisting applicant must also obtain a permit)**. This requirement applies only to peddlers and solicitors, and not to transient merchants. Peddlers and solicitors generally conduct business from house to house, or business to business, while transient merchants conduct business in an approved location on a temporary basis. Transient merchants may have more than one person working at an approved location.

PEDDLERS & SOLICITORS: Permit is valid **only** during the days and hours listed below: **9 a.m. – ½ hour before sunset. Monday – Saturday (No sales on Sundays or Federal Holidays)**

This restriction applies only to peddlers and solicitors, and not to transient merchants. Peddlers and solicitors generally conduct business from house to house, or business to business, while transient merchants conduct business in an approved location on a temporary basis.

*Upon receipt of an application for a permit required by this article, the original shall be referred to the Chief of Police who shall cause such investigation of the applicant's business and moral character to be made as he deems necessary for the protection of the public good. **The Chief of Police shall complete his investigation within one (1) week of receiving the application.***
