*-The City of Mount Pleasant shall be held harmless from any and all damages to persons or property that may occur by reason of or through neglect to perform such work in compliance with Excavation and/or Street Repair, Replacement and Maintenance Specifications Ordinance.*

*-Pursuant to the Underground Facilities Information Act (Iowa Code, Chapter 480), all excavations shall comply with Iowa One Call installation/excavation guidelines. As part of this process, all new construction shall be installed in a manner which does not unnecessarily interfere with existing utility infrastructure already located within the city right-of-way. Additionally, to accommodate future maintenance needs, no new underground installations shall be installed within a 24-inch radius (including directly above or below) an existing underground facility without prior approval.*

*-Pursuant Iowa Code, Chapter 355, all survey monuments, (and "pins"); must be preserved. The excavator must comply with all provisions of Iowa Code, Chapter 355, and other applicable provisions of local, state, and federal regulations. All survey monuments that are disturbed must be replaced by a licensed surveyor in accordance with Iowa Code Chapter 355. The City of Mount Pleasant and any other government authority with jurisdiction reserves the right to require that all monuments that are likely to be disturbed to be identified in accordance with Iowa Code, Chapter 355, before the permit is granted and before excavation begins.*

*-Upon completion of any excavation, all property which was impacted by the excavation shall be restored to its original condition prior to the project. This will include any necessary grading, additional topsoil, and reseeding.*

*-Permit Applications shall be considered active for a period of 90-days from the original date of submission. Inactive projects that are initiated outside the 90-day window shall require a new permit application.*
