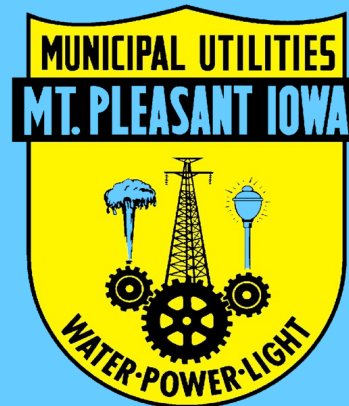

Second, select equipment based on the energy rating and terms and conditions shown in this brochure. **Only new and approved equipment is eligible for energy efficiency rebates.** After installing qualifying equipment, please follow these simple instructions:

1. Equipment must be installed in a home or business that receives utility service from Mt. Pleasant Municipal Utilities.

2. After equipment is installed and operating, complete the online rebate application. The Utilities reserves the right to inspect equipment installation prior to the issuance of rebates.

3. Upload a sales receipt from your dealer, including a copy of the Energy Star Guide from the appliance, manufacturer's name, model/serial number of equipment purchased, and date installed. Equipment must be purchased and installed between **July 1, 2023** and **June 30, 2024**. Rebate applications must be postmarked by **July 15, 2024** to qualify for the **2023-2024** rebate program.

Please allow 6-8 weeks for payment. Your rebate will be in the form of a credit applied to your Mt Pleasant Utilities account. Thank you for participating in our rebate program.
