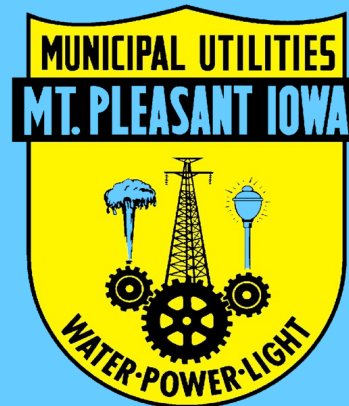

Second, select equipment based on the energy rating and terms and conditions shown in this brochure. **Only new and approved equipment is eligible for rebates.** After installing qualifying equipment, please follow these simple instructions:

1. Equipment must be installed in a home or business that receives utility service from Mt. Pleasant Municipal Utilities.

2. After equipment is installed and operating, **complete the online rebate application.** The Utilities reserves the right to inspect equipment installation prior to the issuance of rebates.

3. Upload a sales receipt from your dealer, including manufacturer's name, model/serial number of equipment purchased, and date installed. Equipment must be purchased and installed between **July 1, 2023** and **June 30, 2024**. Rebate applications must be postmarked by **July 15, 2024** to qualify for the **2023-2024** rebate program.

Please allow 6-8 weeks for payment. Your rebate will be in the form of a credit applied to your Mt Pleasant Utilities account. Thank you for participating in our rebate program.
