Old Business:

- 8a) This is the time set for a Public Hearing for the proposal to amend the Cities Urban Revitalization (tax abatement) ordinance. The State Legislature changed what is eligible for tax abatement and at what percentages could be allowed. The Council must amend our current ordinance to follow the State Law.
- 8b) This Resolution would approve the amendment to the Cities Urban Revitalization Plan to follow the State's new law taking effect July 1, 2024.
