

Mount Pleasant, Iowa, February 28, 2024

The Mount Pleasant City Council met in regular session on Wednesday, February 28, 2024, at 5:30 p.m. at City Hall, 307 East Monroe Street, second-floor meeting room. The meeting was called to order by the Mayor and the roll being called there were present Steven K. Brimhall in the Chair and the following named Councilmembers.

It was moved by Councilmember Griffith and seconded by Councilmember White that the Council approve the following consent agenda items with one roll call motion vote: the minutes of the February 14, 2024, City Council meeting; the payment of bills totaling \$65,959.18; the report of officers.

Roll call vote 5-0. Motion carried.

Bob Welander, Midwest Old Threshers, gave the Council an update on the 2024 Midwest Old Threshers Reunion and thanked the City for their support.

Joy Lapp, Historic Preservation Commission thanked the Council for their support and presented the annual report.

The Council received a letter appealing Potentially Vicious Animal Designation.

Councilmember Griffith moved and Councilmember Batty seconded that the Council approve the agenda as printed.

It was moved by Councilmember Batty and seconded by Councilmember White that the Council read for the third time and adopt the following ordinance:
