The Mount Pleasant City Council met in regular session on Wednesday, December 10, 2025, at 5:30 p.m. at City Hall, 307 East Monroe Street, second-floor meeting room. The meeting was called to order by the Mayor and the roll being called there were present Steven K. Brimhall in the Chair and the following named Councilmembers.

Councilmember Griffith moved and Councilmember McWilliams seconded that the Council read for the second time the following ordinance:

It was moved by Councilmember White and seconded by Councilmember Crull that the Council approve the City's 5-year Capital Improvement Program (CIP) with the FAA for airport improvements. Motion approved, 6-0.

Councilmember Crull moved and Councilmember McWilliams seconded that the Council adopt the following entitled Resolution No. 2025-83:

It was moved by Councilmember Crull and seconded by Councilmember McWilliams that the Council approve the purchase of a 2009 dump truck for the Public Works Department from the Iowa Department of Transportation. Cost of the truck is \$10,000. Motion approved, 6-0.

It was moved by Councilmember Glaha and seconded by Councilmember McWilliams that the Council approve the hiring of Thomas McInerney, Architect for schematic design services-remodeling of 405 E Monroe. Motion approved, 6-0.
