- 9b) This Resolution authorizes the hiring of Jared Dorothy as a Fire Fighter with the Mount Pleasant Fire Department. The Fire Chief approved the hire.
- 9c) This Resolution directs the Building and Zoning Administrator to solicit bids for the demolition of a structure at 403 East Green Street. The property has been deemed to be beyond repair. Gary Shahan, Building and Zoning Administrator will have a report.
- 9d) This Resolution would approve the 2025 Tax Abatement applications that the Building and Zoning Department has collected from various improvements that occurred in 2025.
- 9e) This motion would approve the contract between the City of Mount Pleasant and Mount Pleasant Community Childcare. The City currently has available space at City Hall located at 307 East Monroe Street to host MPCC on a temporary basis. The City will lease three of the former classrooms along with restrooms, gym space and outdoor space free of charge from March 1, 2026 – September 30, 2026.
