

3. Upload a sales receipt from your dealer, including manufacturer's name, model/serial number of equipment purchased, and date installed. Equipment must be purchased and installed within the designated program year.

Please allow 6-8 weeks for payment. Your rebate will be in the form of a credit applied to your Mt Pleasant Utilities account. Thank you for participating in our rebate program.
